PURPOSE OF SALE

This puppy is the result of thoughtful health testing, temperament selection, structural evaluation, and responsible breeding practices. WonderDoodles is committed to producing exceptional family companions through careful genetic selection, ethical breeding, and early developmental enrichment.

Each litter is intentionally planned to preserve and improve the WonderDoodles breeding program. Only those puppies selected by the Seller for future breeding are retained. All remaining puppies are intentionally placed in carefully chosen companion homes where they are expected to be cherished as lifelong family members.

This puppy is sold solely as a companion animal.

No breeding rights are granted or implied under this Agreement.

HEALTH GUARANTEE

Seller certifies that, to the best of Seller's knowledge, this puppy:

- Has received age-appropriate veterinary examinations.
- Has received age-appropriate vaccinations and deworming.
- Has been examined by a licensed veterinarian.
- Appeared healthy at the time of transfer.

Buyer agrees to have the puppy examined by a licensed veterinarian within **72 hours** of taking possession.

If the examining veterinarian diagnoses a serious congenital or hereditary condition that clearly existed prior to transfer, Buyer shall immediately notify Seller and provide written documentation from the examining veterinarian.

Seller reserves the right to obtain an independent veterinary opinion.

If a covered congenital condition is confirmed, Seller may, at Seller's sole discretion:

- Replace the puppy with one of comparable value when available; **or**
- Refund the purchase price upon return of the puppy.

Wonder Doodles

Routine veterinary expenses, parasites, infectious disease contracted after transfer, injuries, allergies, environmental conditions, nutritional deficiencies, obesity, accidental injuries, or conditions resulting from improper care are excluded from this guarantee.

Seller's liability shall never exceed the original purchase price of the puppy.

COMPANION HOME / BREEDING RESTRICTION

Buyer understands that this puppy is being sold exclusively as a companion animal.

Buyer agrees that this dog shall **never** be intentionally bred under any circumstances.

Buyer further agrees that this dog shall never be:

- bred naturally;
- bred through artificial insemination;
- used as a stud dog;
- used as a brood female;
- leased or loaned for breeding;
- advertised or offered for breeding;
- have semen collected or stored;
- have ova or embryos collected or transferred; or
- otherwise be used for any reproductive purpose.

Buyer acknowledges that **no breeding rights are conveyed by this Agreement** and that any intentional breeding constitutes a material breach of this Agreement.

SPAY / NEUTER AGREEMENT

Buyer agrees to have this dog spayed or neutered by 6-9 months unless a different age is recommended by Buyer's licensed veterinarian in writing, taking into consideration the dog's size, physical maturity, orthopedic development, and overall health.

Buyer agrees this dog shall not be bred prior to sterilization.

WonderDoodles

Seller reserves the right to request written verification from Buyer's veterinarian that the procedure has been completed.

LIQUIDATED DAMAGES

Buyer acknowledges that WonderDoodles has invested substantial time, education, financial resources, health testing, genetic selection, temperament evaluation, and responsible breeding practices in developing its breeding program. Buyer further acknowledges that unauthorized breeding would cause substantial and difficult-to-measure damages to the WonderDoodles breeding program, including loss of exclusive breeding opportunities, harm to reputation, and dilution of carefully developed bloodlines.

Accordingly, Buyer agrees that if this dog is intentionally bred in violation of this Agreement, Buyer shall pay Seller liquidated damages in the amount of Fifteen Thousand Dollars (\$15,000.00) for each litter produced, together with Seller's reasonable attorney fees, court costs, investigation costs, expert witness fees (if applicable), and collection expenses, to the fullest extent permitted by applicable law.

Buyer acknowledges that this amount represents a reasonable estimate of damages and is not intended as a penalty.

Seller expressly reserves all other legal and equitable remedies available under applicable law.

LIFETIME RETURN POLICY

If Buyer is unable or unwilling to keep this dog at any time during its lifetime, Buyer agrees to notify Seller immediately.

Seller shall have the **first right of refusal** to:

- accept return of the dog; or
- approve or assist in selecting an appropriate new home.

Buyer agrees that this dog shall **never** be surrendered, sold, gifted, transferred, or relinquished to:

- an animal shelter; rescue organization; pet store; puppy broker; auction;
- research facility; or any similar organization.

Wonder Doodles

Buyer further agrees that ownership of this dog shall **not** be transferred to another individual or organization without first notifying Seller and providing Seller a reasonable opportunity to exercise the first right of refusal described in this Agreement.

No refund for returned dogs.

PROPER CARE

Buyer agrees to provide this dog with:

- routine veterinary care; quality nutrition; routine grooming; appropriate exercise;
- positive training and socialization; safe housing; and lifelong humane care.

Buyer agrees never to neglect, abuse, abandon, or intentionally mistreat this dog.

LIFETIME BREEDER SUPPORT

Seller remains available throughout the lifetime of this dog to answer questions regarding nutrition, training, grooming, behavior, health, and general care.

Buyer is encouraged to contact Seller whenever guidance or assistance is desired.

LIMITATION OF GUARANTEE

Seller makes no guarantee regarding:

- adult size or weight; coat color changes; degree of curl; amount of white markings; reproductive ability; show quality; or future temperament.

These characteristics are influenced by genetics, normal development, nutrition, health, and environmental factors.

USE OF WONDERDOODLES NAME

Buyer agrees not to represent this dog, any offspring, or any future breeding program as being affiliated with or endorsed by WonderDoodles.

WonderDoodles

Buyer shall not use the WonderDoodles name, logo, photographs, pedigrees, or reputation to advertise or promote any breeding program without Seller's prior written permission.

ENTIRE AGREEMENT

This Agreement constitutes the complete agreement between Buyer and Seller.

No oral statements or representations shall modify this Agreement.

Any amendment must be in writing and signed by both parties.

GOVERNING LAW

This Agreement shall be governed by the laws of the State of Texas.

If any provision of this Agreement is found unenforceable, all remaining provisions shall remain in full force and effect.

Venue. Any legal action arising out of or relating to this Agreement shall be brought exclusively in a court of competent jurisdiction located in Gregg County, Texas and Buyer consents to the jurisdiction and venue of such courts.

SELLER'S RIGHT TO DECLINE PLACEMENT

Seller's first responsibility is the lifelong welfare of each WonderDoodles puppy.

Seller reserves the right to refuse or cancel the sale of any puppy at any time prior to transfer of ownership if Seller reasonably determines that placement is not in the puppy's best interest. This may include, but is not limited to, concerns regarding the suitability of the home, changes in the Buyer's circumstances, incompatibility between the Buyer's expectations and the puppy, concerns regarding the puppy's welfare, or any material misrepresentation by the Buyer.

If Seller elects to cancel the sale prior to transfer of the puppy, Seller shall refund all monies paid by Buyer, including the reservation deposit. Such refund shall constitute Buyer's sole remedy, and neither party shall have any further obligation under this Agreement. Seller's decision is made solely in the interest of the puppy's well-being.

BUYER ACKNOWLEDGMENT

Buyer acknowledges that this puppy is the product of years of thoughtful health testing, temperament selection, structural evaluation, and responsible breeding practices.

Buyer understands that this purchase is for the lifelong companionship of this individual dog and **does not include any breeding rights, reproductive rights, or genetic use rights.**

Buyer acknowledges that they have read this Agreement in its entirety, understand all provisions, and voluntarily agree to abide by its terms.
